

Agreement to Accept Risks and Release, Image Consent



This is a binding legal document. Read and understand fully before signing.

Agreement to Accept Risks and Release

I, the undersigned, in consideration of the privilege and benefit to me of being allowed to participate and participating in the Community Academy Program (Program), acknowledge and agree that:

1. I have applied to be accepted into and participate in the Program as a VOLUNTEER, acknowledging that the Program is a completely voluntary opportunity for me, and there is no personal or individual reason why I should not or cannot participate in the program.
2. I understand that I must sign this document as a condition of being accepted into the Program.
3. I am at least 18 years of age and I have full capacity to understand and sign this document.
4. I understand and accept that I am signing a document with potentially significant legal implications and consequences that could be adverse to my interests;
5. I have had ample opportunity to review this document, consult with anyone of my choice about its implications, fully understand it, and now sign it VOLUNTARILY WITHOUT RESERVATION;
6. I understand fully that some activities of this program may involve DANGERS AND SERIOUS RISKS to me and others, including personal injury and property damage and even RISK of death if any extraordinary incident or circumstances were to occur, especially if and when I accompany public safety and other personnel and officials in any ride-along or other Program-related activities when those personnel or officials may or decide to undertake actions or address circumstances that can inherently be part of the RISKS their responsibilities can potentially involve. I have had the chance to fully discuss those RISKS and weigh them. I VOLUNTARILY AND KNOWINGLY ACCEPT AND ASSUME THOSE RISKS.
7. I promise that I will IMMEDIATELY AND COMPLETELY follow any instructions given to me by personnel and officials who are leading or helping with the Program. However, in any circumstance I will not be acting as the County's agent.
8. To the fullest extent permitted by law, without regard to whether there is insurance coverage or an adequate amount of insurance coverage in existence or available, I FOREVER RELEASE from any CLAIMS AND LIABILITY OF ANY KIND FOR DAMAGE TO MY OWN PROPERTY caused by the County of Augusta, its officials, employees, agents and representatives from any and all costs, claims, expenses, causes of action, asserted theories of liability, proceedings, investigations, loss of use and liability by reasons of injury or death to other persons or damage to the property of others caused by or attributable to me in my participation or involvement in the Program.
9. I have not withheld any information from the Program sponsor or personnel or officials.
10. I understand this agreement cannot be changed or revoked by me, and it is legally binding on me and any successor(s) in interest, including but not limited to my estate, my representatives, or beneficiaries.

Consent and Authorization and Release for Unrestricted Taking and Use of Model Images and Video

In consideration of my engagement as a photographed and videoed model, whether my image or outline of my image is used in whole or in part, including a particular feature of my image, the undersigned irrevocably and voluntarily grants consent and authorization for the purpose of ongoing marketing and promotions for the County of Augusta, their officers and employees and promotional affiliates and associates, creative consultants or advisors, legal representatives, independent contractors, agents, and assigns ("Releasees") within the scope of their work related to all County of Augusta marketing and promotions now as follows:

- A. Forever granting the Releasees the unrestricted consent, right and authorization to capture, store, modify and use, publish, disseminate, re-use, transmit, all images and and video of me or aspects of me and in which I may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations in conjunction with my own or a fictitious name or no name, or reproduction of such in color or otherwise, made through any and all media now or hereafter known for promotion, depiction, illustration, art, advertising, trade, or any other purpose whatsoever in whatever medium, including print, non-print, and electronic.
- B. Forever granting the Releasees all rights, including intellectual property rights and an unconditional license, to use such images and video and relinquishing to the Releasees any right that I may have to examine or approve a proof, re-proof, and the completed product or products or the promotional presentation, copy or printed matter that may be used in conjunction with my image or feature regardless of how it may be incorporated or presented.
- C. Forever releasing the Releasees from any liability related directly or indirectly to any blurring, distortion, alteration, modification, optical illusion, or use in composite or aggregated or disaggregated form whether intentional or otherwise, that may occur or be produced in the taking or recording of such image or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy or appropriation of likeness or any other possible theory of liability, whether sounding in tort or contract or otherwise.
- D. Affirming that I am over the age of majority and am without limitation, with the unconditional right to voluntarily execute this document of my own free will and in my own name and having fully and carefully read and entirely understood this document and had the opportunity to consult with legal counsel of my choice at my own expense prior to its execution as a non-assignable document legally binding on me and on my successors in interest and representatives.
- E. To the effect that the subject is under majority, the subject's parent or legal guardian grants such consent to be no less binding to the fullest extent permitted by law.
